- High grounding rate shows effective implementation.
- Completion rate is strong but still leaves ~30% backlog.
- Central funds utilisation is efficient (83% of assistance released already used).
- Impact: Nearly 10,000 urban families now have pucca homes.

Health Infrastructure

Jalandhar DH is one of only five in Punjab with a functional ICU and full line services.

Beds: 470 available vs. 603 required (78%)

Doctors/Specialists: 45 posted vs. 68 required (66%)

Nurses/Paramedics: 101 vs. 225 required (45%)

Major shortages in anaesthetists, dieticians, ANMs, physiotherapists.

CHC/PHC/SC Availability: Only 11 CHCs out of 18 required; 28 PHCs out of 73 required; 198 SCs out of 439 required.

Health Score Calculation:

ICU & line services = 15/15

Doctors = 16.5/25

Specialist shortages = 4.95/15

Total Health Score: 60.9 / 100 → 42.63 / 70

Strengths: Availability of ICU and critical services, adequate beds relative to other districts.

Weaknesses: Severe staffing shortages (doctors, nurses, key specialists) and poor primary health centre coverage.

Data Sources & Limitations

- The Health Data is based on CAG Audit report of 2024 on Performance Audit of Public Health Infrastructure and Management of Health Services in Punjab.
- Housing data is from PMAY Data.
- CAG Audit report of ULB is from 2019-2022 hence data not used.
- AMRUT Survey on water supply and water quality done by Government of India but report is held by Government of India since 2 years hence data not available.
- SMART cities data not used because not relevant to every city of Punjab.
- Government of Punjab has not shared any data in public domain on any socioeconomic or infrastructure or by any department therefore no data is used from that source.

Overall Analysis

The final score of 66 / 100 indicates an above-average performance, primarily driven by strong results in housing. The score is held back by systemic issues in the health sector.

Recommendation for MLA:

- Focus on filling critical healthcare vacancies and improving CHC/PHC/SC coverage.
- Continue monitoring and speeding up completion of remaining PMAY houses.
